For the 2016-17 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as a "HAS NOT BEEN GIVEN ONE OF THESE LABELS".

State law requires that we also report additional information:

- Alanson Public School is a small district that occupies only one building for all K-12 students, therefore the students are simply assigned to the appropriate grade level.
- 2. The School Improvement Plan is a living document and is reviewed each year. Modifications to the plan are made as a result of the latest data. Modifications were made this year to continue focusing in the area of reading and becoming a PBIS (Positive Behavior Supports & Interventions) school.
- 3. We do not have any specialized schools in our district.

- 4. Alanson Public Schools has implemented the Common Core per the Michigan Department of Education and will continue to implement the State's model. All teachers are required to fill out a curriculum map where variances may be made due to the needs of our students.
- 5. Our NWEA results will be in analyzed in June to make proper decisions on programming and curriculum needs.
